Both the Bare Bones and the Intermediate Homebrewing classes were pretty big hits this year. We had 26 attendees turn out on a cold January day for Bare Bones. Everyone there learned how to take a simple ale kit from boil to bottle.

A few weeks later on February 7th we had our second annual Intermediate class. A record setting 41 attendees turn out to learn about yeast starters, kegging, counter flow pressure filling, wort chilling, and grain crushing.

Initial feedback from both events was pretty positive and we'll definitely keep them on the calendar for 2010. Special thanks go out to Mike Rice, Jason Heller, David Glazewski, Mike Schwartz, Jeff Enders, Dan Schlosser, Rich Heller, and Jerry Uthemann for their help with the classes.

Membership Registration Update

The club transition to an annual membership is off and running strong. Over half of the club has made their full or pro-rated payments for 2009. If you haven't made your payment and received your membership card please do so by the end of February in order to avoid interrupted membership services. Remember – Membership brings you: Preference over non-members for beer fest ticket purchases, discounts at two local home brew supply shops (with more discussions in the works), the ability to get a login for the Barons Brew Blog, Preference over non-members when signing up for Brew U courses.

We have three different options that members can use in order to pay this year.

- Use the new Member Dues and Fees Payment page that we've created on the Barons web site. This page utilizes Google Checkout and allows members to renew using their credit card. It's important to note that the Google Checkout functionality prohibits anyone in the club from seeing your credit card information. It's also been tested using the Treasurer's and President's own personal credit cards. - Write out a check for the amount owed in 2009 to the Beer Barons and mail it in to PO Box 270012 Milwaukee, WI 53227.
- Pay the Treasurer the amount owed by check or in cash at the next Barons club meeting.

After you pay your membership fee you'll receive your membership card for 2009 at the following Barons monthly meeting. This membership card will help us speed up the check in line at meetings and provide you at present with discounts on home brewing supplies at two local shops (10% off at either Brew & Grow in Brookfield or Cedarburg Homebrew and Wine).

This year we are also offering club members the option of pre-paying for club meetings when renewing their memberships. Why might you want to take advantage of this option? This pre-payment will cover admission charges for all the regular monthly meetings (including the Christmas party) and insure you from having to pay additional fees for special meetings (like Belgian night). Simply show your pre-paid member card at Baron monthly meetings to get your wrist band and away you'll go.

The details for these options can also be found on the new Member Dues and Fees Payment page on the Barons web site. Members can pre-pay for club meetings either on the web page, at a meeting, or via check mailed to the Barons PO Box. The renew message column on the reference document was put there to direct you towards the appropriate area on the Member Dues and Fees Payment page.

Please be sure to renew your membership by the end of the March club meeting. After that, all memberships from 2008 will be cancelled.

REVERSION TO PREVIOUS DESCRIPTION OF NEWSLETTER EDITOR
TO SECRETARY AND RESTORATION OF DUTIES**

CONSTITUTION ARTICLE III: OFFICERS

Section 1 OFFICERS The officers of the association shall consist of the (1) President, (2) Vicepresident, (3) News Letter Editor, and (4) Treasurer

BY-LAWS—ARTICLE III
OFFICERS AND BOARD MEMBERS

Section 4 DUTIES OF THE NEWS LETTER EDITOR The following are the News Letter Editor's duties:

- a) maintain the official current roll of the membership and provide all officers as well as the Membership Committee with the same
- b) maintain copies of the Constitution and By-Laws
- c) conduct all official membership and Board correspondence, except as otherwise directed by the Board
- d) send out proper notices of all meetings, elections and other official business as directed by the Board
- e) keep and accurate roll of the membership
- f) serve as Chairman of the Newsletter Services Committee
- g) keep an accurate file of all correspondence conducted by all officers and all committee chairmen in the name of the association as well as any correspondence conducted by any other members in the name of the association
- h) publish and distribute the newsletter

The beer can be of any category but the recipe must have over 50% extract. If you are interested in entering the competition bring three 12 – 16 oz bottles of beer that are label free.

The National competition is the one of the toughest competitions a homebrewer can enter, but is a way to get top notch feedback on your beers from some of the highest level judges the AHA has to offer. Entering the National also bring recognition to the Beer Baron's and can score the club points in the Home brewer club of the year competition.

In an effort to help the club I will be heading up the clubs efforts in getting Beer Baron's beers to the 1st round of Nationals. I will be happy to help answer or

get the answer to any questions you may have. Help with getting your beers entered, and shipped. If we get enough beers entered I might even be up for a road trip and deliver the beers.

Regardless of how your beers get entered or delivered to Nationals please make sure to put down The Beer Baron's of Milwaukee as your homebrew club. Entries for the 1st round of Nationals are due between March 28th and April 8th. We are in the Midwest region which means we will be sending our beers up to Northern Brewer in St Paul MN. Cost for the competition is \$14 for non AHA members and \$9 for AHA members. If you're not an AHA member talk to Bruce Buerger about becoming an AHA member.
