Ted Wilinski is having a Light Beer competition on Saturday, June 22nd at Jacobus Park. The get together will start at 12:00noon and judging will begin about 3:00pm.

Last Meeting's Highlights:

May- Jerry Resney, the co-owner and president of the Brewmaster's Pub in Kenosha was our speaker for this meeting. This is a brewpub in some respects similar to the Waterstreet Brewery in Milwaukee. Jerry explained their operation and the ways that they comply with the Federal requirements separating brewing establishments and serving areas. Their solution is novel. A very interesting presentation was followed by a good question and answer period. During and after the presentation, we were allowed to taste two of the beers brewed by Brewmaster's- Kenosha Gold and Royal Dark. Both are All Malt brews with heavier malt flavors.

June-Six new members joined the club this month. Two gentlemen from Sommer-Frey Laboratories spoke to the group. Sommer-Frey is an independent test laboratory that tests yeasts, bacteria and water among other things. They are open from 8:00 to 5:00 weekdays. they were very informative and a good question and answer period followed.

A break was taken and Einbecher Ur-Bock was tasted. Jerry Uthemann was asked to comment on this beer. He said that it was full-bodied with a residual malt taste and darker in color. A good example of a maibock beer.

Rick Spoerl, the home representative of the Perlick Corporation was the next speaker. He had an interesting presentation that started with some information on their plant and a little history of the company and how it flourished during the prohibition era. They are now the largest fitting manufacturer for the brewing industry. They hold the patent for the slide faucet and also manufacture total bar equipment. The glass washing system is their latest innovation and they are also very proud of their Century beer system. Rick brought along some examples of some of the equipment that they make and sell. His presentation was very interesting and quite informative.
