## Important Things to Know For Attending the Meeting In Person

Upon arrival, you will have your temperature taken and will be asked to sign the waiver below that specifies the expectations and precautions we are taking to keep our members safe.

If you are unable or unwilling to meet the expectations, please join us remotely.

## **Beer Barons Event Waiver**

Things you should know before attending this Beer Barons of Milwaukee event.

The venue, Clifford's Supper Club in Hales Corners, WI has relocated tables to account for social distancing and are using commercial grade cleaners that kill viruses such as COVID 19.

• We ask that you leave tables in their current locations and do not move them, orange cones will be used as reminders to socially distance.

We the Beer Barons of Milwaukee have added the following measures to keep you and others attending as safe as possible.

- All attendees will be asked to enter through the banquet hall entrance (located on the West side of the building).
- Upon entering your temperature will be taken and recorded on this waiver.
- The following PPE will be provided for your use: Face Masks, Nitrile Gloves, Disinfectant Wipes, Hand Sanitizer and Sanitized one-time-use pens.
- Disposable cups will be used for each pour at the Jockey Boxes. Jockey Boxes will be separated to encourage social distancing.
- Beverages on the Jockey Boxes will no longer be self-serve; a bartender/server will be present and will serve you at each Jockey Box.
- Face Shields will be made available for all staff/volunteers.

By signing this Waiver, you agree not to hold the Beer Barons of Milwaukee responsible if your contract COVID19 or any other communicable disease. You also confirm that you do not have COVID19, are not ill and have not been in contact with someone who has COVID19.

\*If you participate in bottle shares you do so at your own risk.





## **Instructions for Using Zoom (continued)**



## Ferment whatever you like, BUT it must be 4% ABV or LESS


We have 14 taps total on our Jockey Boxes, March Madness Brewers will have first dibs on entering, after that spots are first come - first get.

## **Treasurer Report**

Happy Brewing Barons. Our biggest expense in June was 2 new jockey boxes, which I informed you about in last month's Treasurer Report. Our club continues to be healthy from a financial perspective as our club bank balance is \$11,732.78, as of 6/30/20.

The Officers decided to continue to pay Clifford's rent even though we have not held a physical general meeting at their location since February 2020. Our agreement with Clifford's is to pay them a minimum of \$100 for meeting in their business every time we have a general meeting, which prior to Covid-19, was every month. If we would happen to have > 100 people attend our general meeting, then the agreement calls for \$1 per person over 100. So as an example, if we had 112 people attend a general meeting, we would pay Clifford's a total of \$112 for that meeting. (Keep in mind, there was only once in all of 2018 & 2019 that we had > 100 people attend our general meeting, and that was the Christmas Party meeting in December 2019 when we had 110 people attend.) So, in general terms, we pay Clifford's \$100 in monthly rent.

We thought the extra \$400 we paid Clifford's (for March, April, May & June) goes a long way with our relationship that we have with them. Also, we believe we are doing our part in helping support a local business in a time of need as many businesses are closing their doors due to the pandemic. Please know that Clifford's is very grateful for our decision to continue to pay them.

In terms of membership, there is no change from last month. We have 119 members as of 6/30/20.



## **Did You Know???**

I recently brewed a doppelbock, which will be going into a rye whiskey barrel soon. A little history behind doppelbocks and why breweries name their doppelbocks with an "ator" ending. Read on (taken from Wikipedia).

Doppelbock or double bock is a stronger version of traditional bock that was first brewed in Munich by the Paulaner Friars, a Franciscan order founded by St. Francis of Paula. Historically, doppelbock was high in alcohol and sweet, thus serving as "liquid bread" for the Friars during times of fasting, when solid food was not permitted. Today, doppelbock is still strong—ranging from 7%—10% or more by volume. It isn't clear, with color ranging from dark gold, for the paler version, to dark brown with ruby highlights for darker version. It has a large, creamy, persistent head (although head retention may be impaired by alcohol in the stronger versions). The aroma is intensely malty, with some toasty notes, and possibly some alcohol presence as well; darker versions may have a chocolate-like or fruity aroma. The flavor is very rich and malty, with toasty notes and noticeable alcoholic strength, and little or no detectable hops (16–26 IBUs). Paler versions may have a drier finish.

The monks who originally brewed doppelbock named their beer "Salvator" (literally "Savior"). Brewers of modern doppelbocks often add "ator" to their beer's name as a signpost of the style; there are 200 "-ator" doppelbock names registered with the German patent office.


